76/16 DECLARATIONS OF INTERESTS

There were no Declarations of Interests.

77/16 PUBLIC PARTICIPATION

There was no public participation.

78/16 The **minutes of the Monthly Meeting** of Heptonstall Parish Council held 1 August 2016 were approved as a correct record.

79/16 TRAINING/DEVELOPMENT

The Clerk confirmed tomorrow evening's training event for Councillors Crowther and Slater had been cancelled, and he had therefore cancelled the authorised cheque for £90.00.

83/16 PLANNING

84/16 DEVELOPMENTS: LAND AT NORTH SLACK

Concern was expressed of the delivery of four x 22 tonnes of breeze blocks at this site, with no knowledge of the implications or permissions.

The Clerk reported he was still awaiting a promised update at this site from the Head of Planning Enforcement. It was resolved to stress the concern and urgency of this matter, and copy to the Head of Development, the Planning Manager for this area as well as Ward Councillor Fenton-Glynn.

It was agreed to follow up on outstanding items identified from the current list.

87/16 NEIGHBOURHOOD PLANNING

Councillor Slater advised the Joint Committee's technical adviser (Dr Lindsay Smales) wished to meet members of the Council in the coming weeks. It was agreed to invite him to attend one hour in advance of the next scheduled monthly meeting of this Council.

Councillor Slater said she would discuss this with Dr Smales, and was thanked for her report.

88/16 REPORT OF PROGRESS/ACTIVITY OF THE TRAFFIC GROUP

Councillor Scarborough reported on his contact with Cllrs Barry Collins and Josh Fenton-Glynn in respect of the possible off-street parking at Valley View Road, Heptonstall.

He had provided a draft survey form for parishioners' opinions which was agreed, and it was resolved to approve the estimated cost of £600 to £700 of production and assisted distribution, thereby proceeding with this aspect.

It was further agreed the results of the survey be balanced between Heptonstall village and the rest of the parish using a suggested overall result of a minimum of 65% of completed forms.

Councillor Scarborough was not only thanked for his report, but also for the extensive work he has already put into this project.
